### Project Background



Ringette Canada is embarking on the development of its 2023-2027 Strategic Plan.

Following the impact of the Covid pandemic, much has changed in the sporting landscape in Canada, in the lifestyles of Canadians and in the expectations they have for sport. At the same time, Ringette Canada is undergoing significant organizational change.

The Strategic Plan being developed is an important "reset" for the organization, which will guide fundamental strategic decisions in the coming years.

The plan is to be developed in 2 phases.

**Phase 1** is intended to be a comprehensive stakeholder consultation process, designed to gather the perspectives and understand the needs and expectations of our member Provincial Sport Organizations, local associations, our athletes and coaches, ringette families, our partners as well as our staff, other NSOs and any other stakeholders. The insights gathered from the consultation process will inform our thinking about key issues and trends, challenges and opportunities, and key strategic priorities.

**Phase 2** will focus on the development, evaluation, and selection of strategic options.

- Begin work no later than February 13, 2023.
- Gather feedback from representatives of the following groups, at a minimum:

   a. The Provincial Sport Organizations, a variety of Athletes, Coaches, Officials, Ringette Canada staff, Ringette Canada Board of Directors
   & Other constituencies as may be determined during the project
- Present a summary of key findings to the Ringette Canada Board of Directors meeting in late April, 2023.

## Submission



Interested firms are asked to submit the following information:

- A list of sport or community organizations for whom they have completed similar work within the last 3 years.
- Contact information for two client references.
- The name/title of the individual from the proponent firm who will be Ringette Canada's principal contact during the engagement.
- A fee proposal.
- Proponent firms should indicate whether they have the competency to support Ringette Canada in Phase 2 (Strategy Development) of the work. Selection for Phase 1 is not dependent on having competency to perform Phase 2, nor does selection for Phase 1 imply that the same proponent will be used for Phase 2.
- Declaration of independence / no Conflict of Interest.
